RECTOR OF DIPONONEGORO UNIVERSITY,

Consider :

- a. that based on the provisions of article 38 paragraph (1) letter m Government Regulation of the Republic of Indonesia Number 52 of 2015 concerning the Statute of Diponegoro University, the Chancellor has the authority to administer a higher education management system;
- b. that to bring order, expedite, and uniform the implementation of education and academic administration both in faculties, schools and universities, an academic schedule is needed;
- c. that to achieve the purpose of letter b as mentioned above, it is necessary to stipulate the Diponegoro University Academic Calendar for the 2021/2022 Academic Year which applies as a guideline for the implementation of education;
- d. that as its embodiment it is necessary to stipulate a Decree of the Chancellor of Diponegoro University;

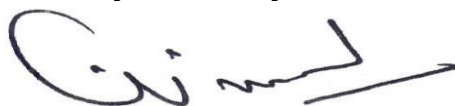
