BY THE GRACE OF GOD ALMIGHTY,
THE RECTOR OF UNIVERSITAS DIPONEGORO,

- Considering :
- a. That to implement Government Regulation Number 52 of 2015 on the Statute of Universitas Diponegoro, it shall be necessary to establish an internal quality assurance system, quality assurance unit organization, and the implementation mechanism at Universitas Diponegoro;
 - b. That based on Article 73 paragraph (6) of Government Regulation Number 52 of 2015 on the Statute of Universitas Diponegoro, it is stipulated that further provisions regarding the internal quality assurance system, quality assurance unit organization, and its implementation mechanism are regulated in Rector Regulation;
 - c. that based on the considerations as referred to in letter a and b, it is deemed necessary to stipulate the

Regulation of the Rector of Universitas Diponegoro on Internal Quality Assurance System, Quality Assurance Unit Organization, and its Implementation Mechanism at Universitas Diponegoro.

CHAPTER I
GENERAL PROVISIONS

Article 1

In this Rector Regulation:

1. Universitas Diponegoro, hereinafter referred to as Undip, is a legal entity state university.
2. The Statutes of Undip are the basic regulation of Undip management which are used as the cornerstone for the formulation of regulations and operational procedures at Undip.
3. Rector is an Undip organ that leads the organization and management of Undip.
4. Bachelor's degree program is an academic education level after high school education conducted by Higher Education Institutions.
5. Faculty is a set of supporting resources, which conducts and manages academic and professional education in one discipline cluster of scientific and technology.
6. School is the element of academic implementer at the Faculty level that is responsible to conduct and/or coordinate multidisciplinary master's degree programs, professional programs, or vocational programs.
7. Department is an element of Faculty/School that supports the implementation of academic activities in one or several branches of science and technology in academic, professional, or vocational education.
8. Study Program is a unit of educational and learning activities that has certain curriculum and learning methods in one type of academic education, professional education, and/or vocational education.

9. Dean is the head of Faculty or School at Undip who is in charge of and responsible for the education implementation in each Faculty or School.
10. Academic quality policy of Undip is directions, guidelines, and references in preparing the implementation, development, and evaluation plans of academic quality assurance at Undip.
11. Academic quality manual is a guideline in implementing academic quality assurance at Undip.
12. Academic Quality Standards are foundations, guidelines, and targets in planning, implementing, and evaluating the curriculum, learning methods, evaluation systems, student admission and guiding systems, research and community service, facilities and infrastructure to support the learning and teaching process.

CHAPTER II

OBJECTIVES AND SCOPE OF THE INTERNAL QUALITY ASSURANCE SYSTEM

Objectives Article 2

The objectives of internal quality assurance system of Undip:

- a. To ensure that every academic service for students is conducted by following the standards;
- b. To realize transparency and accountability to the community, especially parents/guardians of students, regarding the implementation of education in accordance with the standards; and
- c. To encourage all parties/units at Undip to work towards goals by following the standards and continuously strive to improve quality.

Scope Article 3

The scope of internal quality assurance consists of the development and implementation of quality and audit standards in:

- a. education;
- b. research;
- c. community service; and
- d. student affairs.

CHAPTER III DUTIES AND FUNCTION OF QUALITY ASSURANCE

Duties Article 4

The duties of quality assurance are:

- a. Developing quality standards, guidelines of the achievement of quality standards and assessment tools applied in education, research, and community service activities;
- b. Coordinating the implementation of quality assurance activities of education, research, and community service programs in Faculty/School;
- c. Assessing the quality of programs and services in the Faculty/School environment.
- d. Carrying out an evaluation on the results of quality assurance.

Function Article 5

The function of quality assurance unit of Undip is coordinating the quality assurance process towards the programs and activities at Undip to achieve standard/criteria set in ensuring continuous improvement of the programs and activities of Undip.

CHAPTER IV

Article 6
